## **PROCEDURAL ORDER No. 2**

Energhx Green Energy Corporation , carrying on business as Energhx Consulting ("Energhx") filed an application with the Ontario Energy Board, received on June 8, 2010, under section 60 of the *Ontario Energy Board Act, 1998* ("The Act"), S.O. 1998, c. 15, Schedule B to renew its electricity retailer licence. Energhx also filed an application under section 50 of the Act to renew its gas marketer licence. The Board has assigned the applications file numbers EB-2010-0236 and EB-2010-0237, respectively.

In accordance with Procedural Order 1, Board staff filed written interrogatories with the Board and they were delivered to Energhx. The Board notes that the interrogatories were delivered on October 8, 2010, not on October 6, 2010.

The Board decision to proceed by way of written hearing stands. However, the Board considers it necessary to make provision for the following procedural matters.

Please note that this Procedural Order may be amended, and further procedural orders may be issued from time to time.

**THE BOARD ORDERS THAT:**

1. The Board recognizes that the Board staff interrogatories were delivered on October 8, 2010. Accordingly, Energhx shall file with the Board complete responses to the interrogatories no later than **October 27, 2010**.
2. If Board staff wishes to make a submission, Board staff must file that submission with the Board, and deliver it to the applicant by **November 10, 2010**.
3. If Energhx wishes to file a response to a submission, the response must be filed with the Board by **November 24, 2010**.

All filings to the Board must quote file numbers EB-2010-0236 and EB-2010-0237, be made through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca), and consist of two paper copies and one electronic copy in searchable/unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.oeb.gov.on.ca](http://www.oeb.gov.on.ca). If the web portal is not available you may email your document to the address below.
