This letter is in response to the materials filed by the Wahgoshig First Nation on Tuesday October 12, 2010.

Contrary to the statement regarding the provision of materials, counsel for Wahgoshig was provided with materials. Attached are the courier slips and the emails confirming the information was provided.

We have had a preliminary review of the materials submitted on behalf of the Wahgoshig First Nation and it is Detour's position that the majority of the material is irrelevant to the issues before the Ontario Energy Board. In procedural order number 1, the Board confirmed its jurisdiction

The Board's jurisdiction to consider issues in a section 92 leave to construct case is limited by sub section 96(2) of the OEB Act which states:

(2) In an application under section 92, the Board shall only consider the following when, under subsection (1), it considers whether the construction, expansion or reinforcement of the electricity transmission line or electricity distribution line, or the making of the interconnection, is in the public interest:

1. The interests of consumers with respect to prices and the reliability and quality of electricity service.

2. Where applicable and in a manner consistent with the policies of the Government of Ontario, the promotion of the use of renewable energy sources. 2009, c. 12, Sched. D, s. 16.

The materials filed by the Wahgoshig First Nation indicate that a claim was filed in 1995 with Indian and Northern Affairs Canada who denied the claim in August of 2010. Further, it appears that Wahgoshig First Nation may have the ability to make a monetary claim against the federal government under the *Specific Claims Tribunal Act*. As such, the information is not relevant to the items to be considered by the Board in this proceeding.

Detour therefore requests the Board to proceed to issue a procedural order establishing a schedule for the remainder of the proceeding. Detour submits a written proceeding is appropriate. This letter is being filed on RESS.





We are counsel to Detour Gold Corporation ("**Detour**" or the "**Applicant**").

We have received requests for intervenor status from the Independent Electricity system Operator ("**IESO**"), Earthroots, the Wahgoshig First Nation and possibly the MoCreebec.

Detour has no objection to the granting of intervenor status to any of the parties identified. If the MoCreebec decide to request intervenor status after the stipulated period has elapsed, Detour requests the Board ensure that no delay in this proceeding result from such late intervention.

Earthroots and the Wahgoshig First Nation have each identified environmental issues as areas of concern regarding the project. Both organizations were involved in the recently completed environmental assessment process. As the Board's jurisdiction for leave to construct involving transmission lines is restricted, Detour would request the Board remind parties to address only those issues before the Board in this application.

Detour suggests the Board follow its Practice Direction on Coast Awards and indicate which parties are eligible to make a claim for costs at the conclusion of the proceeding. Detour reserves its rights to make submissions regarding the costs claims of any parties.

Detour submits that an oral hearing is not warranted as the issues are well defined. However, Detour would suggest that the Board issue a procedural order for interrogatories and determine if an oral hearing is required after the completion of the interrogatory phase.
