

As far as a rate change for delivery, I don't believe they need to increase them at all. Horizon is already profiting greatly from the time of use charges, that they can handle some of the cost. Utilities are a necessity for everyone. I understand that to be viable you need to make some gains, but I think their gains should be more controlled than they have been. Horizon and other such corporations servicing the whole country are providing a necessary commodity, without which life would be difficult for us all. The consumer should not be blamed all the time for requiring a commodity that Horizon provides. Most of us try very hard to conserve, and reap no rewards for our efforts. I am starting to think that the 'conservation hype' is just a ploy to make it easier to lay blame on the consumer and make us believe it is because of our demands that rates need to rise.
