Managers Summary

Halton Hills Hydro Inc. has followed the direction of the Board policies and guidelines contained in Appendix D: Filing Requirements for 2007 Rate Adjustments of the December 20, 2006 "Report of the Board on the Cost of Capital and 2nd Generation Incentive Regulation for Ontario's Electricity Distributors". Upon analysis of the model, modest increases of typically less than 1% in distribution rates for all customer classes will be effective May 1, 2007. Our model is consistent in all respects with the filing guidelines.

Therefore, the model indicates the following rates will be implemented by bill pro-ration May 1, 2007.
