## Re: Toronto Hydro-Electric System Limited's ("THESL") 2011 Electricity Distribution Rate Application OEB File No. EB-2010-0142

THESL is in receipt of the Board's Issues List Decision and Procedural Order No. 2 dated November 11, 2010. On page 5, the Board has directed that the issue of recovery of late payment penalty ("LPP") settlement amounts be removed from the Approved Final Issues List. This issue will be dealt with in the Board's generic proceeding EB-2010-0295.

Accordingly, a number of updates are required to THESL's pre-filed evidence in EB-2010-0142 to reflect this direction. Pre-filed evidence related to LPP is easily separated from the remainder of THESL's evidence submitted in this proceeding since it is a single amount, transformed into rate riders, and presented in various schedules. Rather than issue bluepage updates to reflect the severing of the related LPP evidence, THESL proposes to reflect the severance of this issue at the time of rate finalization.
