Please be advised that you did not addressed my concerns regarding Milton Hydro Distribution Inc. failure to follow the Ontario Energy Board Act, 1998 and/or the Statutory Powers Procedure Act by failing to advertise in the highest paid circulation newspaper in the area. The Milton Champion does not have the highest paid circulation in the area and this was one of the factors in my request to have these hearings suspended.

Also, you did not address my concern about the Board's November 19, 2010 letter to me which stated "no decision has yet been made as to whether the Board will hold written or oral hearing..." This contradicts the published notice on Sept. 23rd which states: "The Board intends to proceed with this application by way of a written hearing..." Clearly the decision had been made by the Board as to the process which will be followed in these hearings. Further, the Notice Of Application stated: "If you object to the Board proceeding in this fashion, your letter of intervention must state the type of proceeding you believe to be necessary and the reasons why." My letter of October 2nd, 2010 stated my objection to a written hearing. The Board has ignored my request and has made no ruling on my request, but has proceeded with the hearing in written format

with a vague statement about my request will be considered in due course. How can my request be considered after the hearings have started in a written format?

The December 3rd, 2010 meeting in Toronto has been scheduled despite my request to have meetings held in Milton, Ontario in order to allow the public affected by this request for increase an opportunity to attend, and to allow me to participate as an intervenor in this hearing. This request has received no ruling from the Board. It is not possible for me to travel to Toronto due to health reasons. This request was made in my October 2nd, 2010 letter to The Board.
