Re: Request for Confidential Treatment of Information Associated with Great Lakes Power Transmission LP's Application for 2011 and 2012 Transmission Rates (EB-2010-0291)

We are counsel to Great Lakes Power Transmission LP ("GLPT") in respect of GLPT's Application for 2011 and 2012 Transmission Rates (EB-2010-0291) (the "Application"). The Application was filed on September 29, 2010.

In parallel with the filing of the Application and written evidence, on behalf of GLPT we are hereby filing a request for the confidential treatment of certain information which is intended to form part of the written evidence in support of the Application (the "Confidentiality Request"). This Confidentiality Request is being filed in accordance with the Board's *Practice Direction on Confidential Filings*.

The purpose of this Confidentiality Request is to protect the confidentiality of certain information that is required by the IESO for public security reasons to be kept confidential. Public disclosure of the information would be detrimental to GLPT as it would cause GLPT to act contrary to the IESO's requirements. Moreover, due to the public security-related objectives of the underlying requirements, disclosure would give rise to public security risks.

The nature of the risks are described further within the confidential version of the document contained in **Attachment "A"**. GLPT seeks confidential treatment of the document contained in Attachment "A" in its entirety.

A non-confidential version of the document that is the subject of the Confidentiality Request is provided in **Attachment "B"**.
