Re: Board File Number EB-2007-0853 – NOW Inc Response to Interrogatories

Northern Ontario Wires Inc. submits the following in response to the interrogatories issued December 5, 2007 for the above proceeding.

Ref.: 2008 IRM Model, Sheet 2 (2007 Rate Classes)

1. Rate Classification: General Service 50 to 1,499 kW

Interrogatory - A review of your current 2007 Board approved Tariff of Rates and Charges does not include this rate classification. However, 2007 Board approved Tariff of Rates and Charges does include the General Service 50 to 4,999 kW rate classification, which you did not enter on sheet 2 of the model.

Response - Error - The use of Rate Classification 50 to 1,499 kW is an error and should have indicated Rate Classification General Service 50 to 4,999 kW. We do not have a Rate Classification General Service 50 to 1,499 kW. Accordingly the information input on Sheet 3 for Rate Classification General Service 50 to 1,499 kW should have been input as Rate Classification 50 to 4,999 kW.

2. Monthly Rates and Charges for General Service 50 to 1,499 kW

Interrogatory – A review of your current 2007 Board approved Tariff of Rates and Charges shows “\$/kW” as being the unit for the:

- Distribution Volumetric Rate
 - Regulatory Asset Recovery
 - Retail Transmission Rate – Network Service Rate, and
 - Retail Transmission Rate – Line and Transformation Connection Service Rate
- You have not selected a unit for these rates (i.e., cells D170,D173,D174, and D175 were left blank).

Response – Error - As per above, this category should have been reported as Rate Classification: General Service 50 to 4,999 kW. The unit associated with this Classification should have been reported as “\$/kW” for the:

- Distribution Volumetric Rate
- Regulatory Asset Recovery
- Retail Transmission Rate – Network Service Rate, and
- Retail Transmission Rate – Line and Transformation Connection Service Rate

3. Monthly Rates and Charges for Unmetered Scattered Load

Interrogatory – A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge should include the descriptor “(per connection)”.

Response – Error - The Service Charge for Unmetered Scattered Load should include the descriptor “(per connection)”

4. Monthly Rates and Charges for Unmetered Scattered Load

Interrogatory – A review of your current 2007 Board approved Tariff of Rates and Charges shows “\$/kWh” as being the unit for the:

- Distribution Volumetric Rate
 - Regulatory Asset Recovery
 - Retail Transmission Rate – Network Service Rate, and
 - Retail Transmission Rate – Line and Transformation Connection Service Rate
- You have not selected a unit for these rates (i.e., cells D186, D189, D190, and D191 were left blank).

Response – Error - The unit associated with this Classification should have been reported as “\$/kWh” for:

- Distribution Volumetric Rate
- Regulatory Asset Recovery
- Retail Transmission Rate – Network Service Rate, and
- Retail Transmission Rate – Line and Transformation Connection Service Rate

5. Monthly Rates and Charges for Street Lighting

Interrogatory – A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge should include the descriptor “(per connection)”.

Response – Error -The Service Charge for Street Lighting should include the descriptor “(per connection)”

6. Monthly Rates and Charges for Street Lighting

Interrogatory – A review of your current 2007 Board approved Tariff of Rates and Charges shows “\$/kW” as being the unit for the:

- Distribution Volumetric Rate
 - Regulatory Asset Recovery
 - Retail Transmission Rate – Network Service Rate, and
 - Retail Transmission Rate – Line and Transformation Connection Service Rate
- You have selected ‘\$/kWh’ for these rates (i.e., cells D202, D205, D206, and D207 show \$/kWh).

Response – Error - The unit associated with this Classification Street Lighting should have been reported as “\$/kW” for:

- Distribution Volumetric Rate
- Regulatory Asset Recovery
- Retail Transmission Rate – Network Service Rate, and
- Retail Transmission Rate – Line and Transformation Connection Service Rate

7. Monthly Rates and Charges for Allowances

Interrogatory – A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the unit for “Transformer Allowance for Ownership – per kW of billing demand/month” should be “/kW, rather than “\$”

Response – Error - The unit for “Transformer Allowance for Ownership – per kW of billing demand/month” should be “\$/kW”, rather than “\$”.
