The Ontario Energy Board has now issued its Notice relating to your electricity transmission revenue requirement and rates application. Please note that you must publish the notice within fourteen days of the date of this letter. If publication is impossible within fourteen days, you must inform the Board's case manager immediately.

You are directed:

1. To arrange immediately for the enclosed English version of the Notice, headed with the Ontario government logo and the words "Ontario Energy Board", to be published in one edition of the English language newspaper with the highest paid circulation in Niagara West Transformation Corporation's service area; (**Note:** Please make it clear that invoices regarding publication are not to be sent to the Board);
2. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on:
 - all local distribution companies that WNTC serves;
 - all large users that WNTC serves;
 - Independent Electricity System Operator;
 - Ontario Power Authority;
 - Association Of Power Producers Of Ontario;
 - Consumers Council of Canada;
 - Vulnerable Energy Consumers Coalition;

- Association of Major Power Consumers of Ontario;
 - Canadian Manufacturers and Exporters Association;
 - Energy Probe;
 - Pollution Probe;
 - Schools Energy Coalition; and
 - Electricity Distributors Association
3. To file with the Board an affidavit proving publication and service of the Notice immediately thereafter;
 4. To make a copy of the application and evidence available for public review at Niagara West Transformation Corporation's office in Grimsby, Ontario; and
 5. To provide a copy of the application and evidence to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
