**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*,  
S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Hydro One  
Brampton Networks Inc. for an order approving just and  
reasonable rates and other charges for electricity distribution  
to be effective January 1, 2011.

### **PROCEDURAL ORDER No. 5**

Hydro One Brampton Networks Inc. ("Hydro One Brampton") filed an application with the Ontario Energy Board (the "Board") on June 30, 2010 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Hydro One Brampton charges for electricity distribution, to be effective January 1, 2011.

Procedural Order No. 1, issued by the Board on August 26, 2010, approved a number of intervention requests and established a schedule for the delivery of interrogatories and responses, a technical conference and a settlement conference.

On October 8, 2010, the Board issued Procedural Order No. 2 setting out dates for parties to provide submissions on the response to an interrogatory for which Hydro One Brampton requested confidential treatment.

On November 3, 2010, the Board issued its Decision on Confidentiality and Procedural Order No. 3 establishing dates for parties to provide submissions on further procedural steps in this proceeding and, in particular, on which issues should be addressed through written submissions and which, if any, should be considered as part of an oral hearing.

Procedural Order No. 4, issued by the Board on November 17, 2010 established dates for an oral hearing to allow parties to clarify specific issues in this proceeding. The oral hearing was convened on December 6, 2010 and concluded on December 7, 2010.

The Board has determined further procedural steps to allow parties to provide written submissions on this application.

The Board considers it necessary to make provision for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

**THE BOARD ORDERS THAT:**

1. Hydro One Brampton shall file an Argument-in-Chief or similar document with the Board and deliver it to intervenors by **December 17, 2010**.
2. Board staff shall file a written submission, if any, with the Board, and deliver it to Hydro One Brampton and other intervenors, by **January 14, 2011**.
3. Intervenors who wish to make a written submission on the application must file that submission with the Board, and deliver it to Hydro One Brampton and other intervenors by **January 18, 2011**.
4. If Hydro One Brampton wishes to respond to a submission, the response must be filed with the Board and delivered to intervenors by **January 25, 2011**.

All filings to the Board must quote the file number, EB-2010-0132, be made through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.oeb.gov.on.ca/OEB/Industry](http://www.oeb.gov.on.ca/OEB/Industry). If the web portal is not available, parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
