**IN THE MATTER OF** the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B) pursuant to Section 90(1);

**AND IN THE MATTER OF** an application by Enbridge Gas Distribution Inc. for an Order granting leave to construct a natural gas pipeline in the City of Mississauga and in the City of Brampton in the Region of Peel.

## **PROCEDURAL ORDER No. 2**

Enbridge Gas Distribution Inc. ("Enbridge" or EGDI") has filed an application with the Ontario Energy Board on September 30, 2010, under section 90 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, Schedule B for an order granting leave to construct approximately 270 metres of 323.9 millimetre (12 inch) diameter extra high pressure steel pipeline (the "pipeline") to accommodate the proposed grade separation of Torbram Road and the Weston Subdivision railway tracks. The Board has assigned the application file number EB-2010-0241.

The proposed pipeline route begins at the approximately 105 metres west of Torbram Road and ends approximately 115 m east Torbram Road.

The Board issued a Notice of Application and Hearing ("Notice") on November 2, 2010. Enbridge served the Notice as directed by the Board. No party requested participation in this proceeding.

The Board issued a Procedural Order No. 1 on December 2, 2010 setting a timeline for a written proceeding. Board Staff sent interrogatories to Enbridge on December 8, 2010. According to the established timeline Enbridge was to file the responses by December 14, 2010. On December 10, 2010 Enbridge asked the Board for an extension of time to respond to the interrogatories until December 16, 2010.

The Board grants the request and sets the adjusted timeline in this procedural order.

At this time the Board considers it necessary to make provision for the following procedural matters. Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

**THE BOARD THEREFORE ORDERS THAT:**

1. The Applicant shall file with the Board complete responses to the Board Staff interrogatories no later than **Thursday, December 16, 2010**.
2. Board staff who wish to make written submissions on the application shall file the submissions with the Board and deliver them to by **Thursday, December 23, 2010**.
3. Enbridge may reply to any submissions received by filing reply submissions with The Board by **Thursday, December 30, 2010**.

All filings to the Board must quote file number EB-2010-0310, be made through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.

If the web portal is not available you may email your document to the [BoardSec@oeb.gov.on.ca](mailto:BoardSec@oeb.gov.on.ca). Those who do not have computer access are required to file seven paper copies. If you have submitted through the Board's web portal an e-mail is not required.
