Letter of Direction - REVISED

Dear Ms. Cooledge:

**Re: Innisfil Hydro Distribution Systems Limited
2008 Incentive Regulation Mechanism (2008 IRM) Rate Application

The Ontario Energy Board issued a Letter of Direction on November 12, 2007. Since you were unable to fulfill the directions within the allotted time, the Ontario Energy Board has issued a revised Notice of Application and Written Hearing relating to your 2008 IRM application. Please note that you must publish the notice within fourteen days of the date of this letter. If publication is impossible within fourteen days, you must inform the Board staff contact given at the bottom of this letter immediately.

You are directed:

- 1) To arrange immediately for the enclosed English version of the Notice, headed with the Ontario government logo and the words "Ontario Energy Board", to be published in one issue of the English language newspaper having the highest paid circulation, according to the best information available, in Innisfil Hydro Distribution Systems Limited's service area. Publication must be complete within fourteen days of the receipt of this letter.

Please note that invoices regarding publication are not to be sent to the Board.

- 1) If Innisfil Hydro Distribution Systems Limited is a host distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its embedded distributor(s).
- 2) To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter.
- 3) To make a copy of the application and evidence, and any amendments thereto, available for public review at Innisfil Hydro Distribution Systems Limited's office and on its website, if available; and,
- 4) To provide a copy of the application and evidence, and any amendments thereto, to any intervenor who requests a copy.
