
Milton Hydro Distribution Inc. filed an application seeking approval to increase the Delivery Charges on residential and general service customers' electric bills on August 27, 2010.

A Proposed Settlement Agreement was filed with the Ontario Energy Board in December, 2010.

The Proposed Settlement Agreement fails to clearly outline the impact of the proposed increase to residential customers' electric bill for the Delivery Charge which is the focus for this application.

The attached Monthly Impact Statement should be included in the Settlement Agreement with the Ontario Energy Board. It clearly outlines the Current Monthly Delivery Charge and the Revised Monthly Delivery Charge. Any agreement with the Ontario Energy Board which impacts on the Residential Customers' Electric Bill should be outlined so the increase is transparent and easily understood. The accuracy of the attached Impact Statement has been verified by Mr. Cameron McKenzie at Milton Hydro Distribution Inc.

CURRENT DELIVERY CHARGE PER MONTH 2010-(Usage 800kwh and 828kwh)

Monthly Service Charge	\$15.87 (\$13.71+2.16 smart meter charge)
Distribution Charge @.0092kwh x 800	7.36
Trans. Network @.0059kwh x 828*	4.89
Trans. Connection @.0047kwh x 828*	3.89
Total Charges	\$32.01

REVISED DELIVERY CHARGE PER MONTH – EFFECTIVE 2011

Monthly Service Charge	\$13.32 (\$14.86-\$1.54 smart meter charge)
Distribution Charge @.0134 kwh x 800	10.72 (% increase 31%)
Trans Network @ .0055 kwh x 829*	4.56
Trans. Connection @ .0046kwh x 829	3.87
Total Charges	\$32.47

This represents a \$.46 cent monthly increase in delivery rate or a 1.44% total delivery charge
