AND IN THE MATTER OF an application by Union Gas Limited for an Order granting leave to construct a natural gas pipeline in the in the City of Quinte West, County of Hastings.

PROCEDURAL ORDER No. 1

Union Gas Limited ("Union") filed an application with the Ontario Energy Board on November 11, 2010, under section 90 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, Sch. B for an order granting leave to construct approximately 11.7 kilometres of 6 inch diameter and 1.2 kilometres of 8 inch diameter natural gas pipeline (the "proposed pipeline"), in the City of Quinte West, County of Hastings. The Board has assigned the application file number EB-2010-0329.

The Board issued a Notice of Application and Written Hearing ("Notice") on November 30, 2010. Union served the Notice as directed by the Board. There were no intervenor requests made in this proceeding. On December 16, 2010 the Board did receive a letter of comment from Alderville First Nation who stated that the proposed project would have a "minimal potential to impact our First Nations' rights" and wished to be kept "apprised of any archaeological findings, burial sites or any environmental impacts, should any occur."

At this time the Board considers it necessary to make provision for the following procedural matters. Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

THE BOARD THEREFORE ORDERS THAT:

- 1. If Board staff seeks information and material from Union that is in addition to the evidence filed with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to Union on or before **Monday, January 10, 2011**.
- 2. Union shall file with the Board complete responses to the interrogatories no later than **Monday, January 17, 2011**.
- Board staff may make written submissions on the application and if so, shall file the submissions with the Board and deliver them to Union by Monday, January 24, 2011.
- 4. Union may reply to any submissions received by filing reply submissions with the Board by **Monday**, January 31, 2011.

All filings to the Board must quote file number EB-2010-0329, be made through the Board's web portal at <u>www.errr.oeb.gov.on.ca</u>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.
