EB-2010-0229 – Hydro One Networks Request for Exemptions to the DSC Relating to Capacity Allocation Issues – Table of Projects

Consistent with Item 3 of the Board's Order in its Decision and Order dated December 20, 2010, Hydro One is filing the attached Table of Projects.

Of the twelve projects:

- Five are awaiting the proponent to apply and pay for a SIA and Transmission CIA;
- Four have had their SIA and Transmission CIA applications filed; and
- Three projects require administrative work by Hydro One before applying for the SIA and Transmission CIA.

Hydro One also takes this opportunity to inform the Board of its compliance with the other items in the Board's Order, as follows.

Item 1: The Board's Decision directs the Company to establish deferral accounts and to record certain capital and OM&A costs. Hydro One will establish these accounts and will record the expenditures in a manner consistent with the Smart Meter project. These accounts will be used to determine the revenue requirement associated with the specified expenditures.

Item 2: The attached table identifies the individual projects by their project number only. Hydro One is consulting with Board Staff how the additional information requested (generator name and project) may be provided without breaching customer confidentiality.

Item 4: Hydro One distributed the Board's Decision and Order on this application to the affected generators on December 29, 2010.

Paper copies of the Table are provided. In addition an electronic text-searchable Acrobat copy of the Table has been filed using the Board's Regulatory Electronic Submission System (RESS) and the proof of successful submission slip is attached.
