Ms. Shewchun's e-mail Submission of January 10, 2011**

On January 10, 2011 Ms. Shewchun submitted an e-mail to the Board Secretary and copied Milton Hydro Distribution Inc. ("Milton Hydro") in response to Milton Hydro's January 4th, 2011 letter filed with the Ontario Energy Board ("OEB") and intervenors of record. Milton Hydro's January 4th letter referenced the Proposed Settlement Agreement and in particular Schedule L – Summary of Updated Customer Impacts found at page 56 of the Proposed Settlement Agreement. This letter was filed with the OEB in order to update the delivery charge components used in the calculations prepared by Ms. Shewchun and submitted to the OEB on January 3rd, 2011.

In the January 10th e-mail submission, Ms. Shewchun included a table prepared by Milton Hydro. Milton Hydro provided this table in order to assist Ms. Shewchun in understanding the calculations of the delivery charge portion of a customer's bill and any potential delivery charge impacts. The information provided in this table was based on preliminary data provided in the "first draft" of the Proposed Settlement Agreement, which was subsequently updated in the final Proposed Settlement Agreement.

Ms. Shewchun was advised on December 18, 2010 that this information was superseded and that the revised document would be available on the OEB's public domain on December 20, 2010. This e-mail correspondence was forwarded to the OEB by Ms. Shewchun and it is therefore also available on the

public record. On December 22, 2010, Milton Hydro forwarded Ms. Shewchun the link to the webdrawer as Ms. Shewchun advised that she was unable to locate the document.

At no time has Milton Hydro disputed Ms. Shewchun's calculation method rather the delivery charges used by Ms. Shewchun do not reflect the final Proposed Settlement Agreement.

As provided in Milton Hydro's January 4th letter and Schedule L of the Proposed Settlement Agreement, the delivery charge impact for a Residential customer using 800 kWh per month is 2.07% or \$0.66 per month.
