A review of Grimsby Power's current 2007 Board approved Tariff of Rates and Charges indicates that the service charge is applied on a "per connection" basis, however your 2008 model does not reflect this.

3. Specific Service Charges for Customer Administration

A review of Grimsby Power's current 2007 Board approved Tariff of Rates and Charges indicates that the service call- customer-owned equipment charge is \$30.00, however your 2008 model does not reflect this.

RESPONSE: As noted above, the charge for Service Call – Customer-owned Equipment should be \$30.00.

4. Specific Service Charges for Non-Payment of Account

A review of Grimsby Power's current 2007 Board approved Tariff of Rates and Charges indicates that the collection of account charge and disconnect/reconnect charges (cells 415 to 420) are applied on a "\$" basis, however your 2008 model does not reflect this.

RESPONSE: As noted above, the collection of account charge and the disconnect/reconnect charges (cells 415 to 420) are applied on a "\$" basis.

Ref.: 2008 IRM Model, Sheet 6 (K-Factor Derivation)

5. PILs Allowance for K- Factor Derivation

A review of Grimsby Power's 2007 model shows the PILs Allowance value to be \$360,248, however your 2008 model does not reflect this.

RESPONSE: As noted above, the PILS Allowance in Sheet 6, Box U should be \$360,248.
