This letter acknowledges receipt on December 16, 2010 of your application for an electricity generator licence under the Feed-in Tariff Program. The Board has assigned File Number EB-2010-0387 to this matter. Please refer to this number in all future correspondence to the Board regarding this matter.

Your application is currently incomplete and cannot be processed until the following has been filed:

- You have submitted four applications for electricity generator licences under the Feed-in Tariff Program and a cheque in the amount of \$400. Your applications identify four facilities with a combined capacity of 22 MW and states that you are seeking an operator qualification for each facility.
  - Please confirm that you are requesting one licence with the following four facilities identified on this licence:
    - Big Beaver Falls;
    - Camp Three Rapids;
    - White Otter Falls; and
    - Old Woman Falls.
  - Please note that as the combined capacity of the identified facilities is above 10MW, you are required to submit an application fee of \$1000.

- Therefore, please submit a cheque or money order in the amount of \$600 (Canadian funds) made payable to the Ontario Energy Board.
- Please provide the address for each facility including municipality/Town...etc.
- Please confirm that the distribution lines and associated transformers identified on the applications for each of the four generation facilities will be wholly owned by their respective owners and that Hydromega Services Inc. will only operate those assets. If this understanding is incorrect, please provide full particulars.
- Section 12, Page 7 of the Application: a signature is provided on this page. However, the name of the applicant and the date the application was signed is not indicated. Please provide the required information under section 12, page 7 of the application form and resubmit the page.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue a letter indicating the expected date on which a decision and/or order may be rendered.
