

**ONTARIO ENERGY BOARD**

Gas Distribution Inc. for an order canceling the  
existing certificates of public convenience and

incorporated within the Township of South Glengarry  
and replacing these with a single certificate of public  
convenience and necessity for the Township of South  
Glengarry.

**A P P L I C A T I O N**

**PARTIES**

1. Enbridge Gas Distribution Inc. (the "Applicant") is an Ontario corporation with its head office in the City of Toronto.
2. The Corporation of the Township of South Glengarry (the "Corporation") is a municipal Ontario corporation with its head office at 6 Oak Street, P.O. Box 220, Lancaster, Ontario, K0C 1N0.

**HISTORY**

3. On January 1, 1998 the Township of Charlottenburgh, the Township of Lancaster, and the Village of Lancaster amalgamated to form the Township of South Glengarry. Attached hereto and marked as Schedule "A" is a map showing the location of the Township of South Glengarry (the "Municipality").
4. The Applicant is presently serving the Municipality pursuant to a municipal franchise agreement with the former Township of South Glengarry. The Applicant has certificates of public convenience and necessity for (i) the former Township of Charlottenburgh (FBC 195), and (ii) the former Township of Lancaster (FBC 198).

The Model Franchise Agreement (and related by-law) are attached hereto and marked as Schedule "B". The certificates of public convenience and necessity are attached hereto as Schedule "C".

RELIEF REQUESTED

5. The Applicant hereby applies to the Board for the following:

- (i) an order, pursuant to subsection 8(2) of the *Municipal Franchises Act*, R.S.O. 1990, c. M. 55, as amended (the "Act"), canceling the Applicant's existing certificates of public convenience and necessity for the Township of Charlottenburgh, and the Township of Lancaster and replacing them with a certificate of public convenience and necessity for the Township of South Glengarry.
