**Re: Enbridge Gas Distribution Inc. ("Enbridge") Application for Consolidating Certificate of Public Convenience and Necessity ("Certificate")
with the Township of South Glengarry ("Township")**

Enbridge operates in the Township pursuant to one municipal franchise agreement; the South Glengarry agreement dated March 9, 1998 (the "Current Agreement"). This agreement was granted by the Board under sections 9 and 10 of the *Municipal Franchises Act*. Enbridge wishes to apply to the Ontario Energy Board ("Board") for a certificate of public convenience and necessity ("PCN") for the former geographical area known as the Village of Lancaster (the "Village"), the only area where Enbridge does not currently hold a Certificate within the Township. As such, Enbridge would like to request a consolidating Certificate for the Township that would, in effect, replace Enbridge's existing Certificates for the franchise area.

By way of background, on January 1, 1998 the Township of Charlottenburgh, the Township of Lancaster and the Village amalgamated to form the Township of South Glengarry. Enbridge has a certificate for the former Township of Charlottenburgh (FBC 195) and the former Township of Lancaster (FBC 198), but not for the Village. Enbridge entered into a 30 year franchise agreement on January 11, 1971 with the Village, and appears to have been distributing gas to the Village on that authority, but without a PCN. This oversight was repeated in Enbridge's ratification of the Current Agreement.

By way of the attached, Enbridge is therefore applying for a consolidating PCN and awaits the favour of your reply.
