LETTER OF DIRECTION

Leave to Construct

The Ontario Energy Board has now issued its Notice relating to your Leave to Construct application. Please note that you must publish the notice within fourteen days of the date of this letter. If publication is impossible within fourteen days, you must inform the Board staff contact given at the bottom of this letter immediately.

You are directed:

- 1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipelines.
- 2. To immediately serve a copy of the Notice, location map together with a copy of the relevant application, either personally, by courier or by registered mail, upon the clerks of the affected municipalities, upon all property owners and encumbrancers with lands or interest in lands identified in the affidavit of search of title referred to in #1 above.

- To immediately serve a copy of the Notice, the location map together with a copy of the relevant application, either personally, by courier or by registered mail, upon Petroleum Resources Centre, Ministry of Natural Resources, London Ontario.
- 4. To immediately have the Notice published, headed with the Ontario Government logo and the words "Ontario Energy Board", in one issue of a daily newspaper or newspaper having the highest paid circulation, according to the best information available, in the Township of St. Clair, Lambton County.

NOTE A: Please make it clear to each newspaper that the publication invoice is to be sent to Union Gas Limited, not to the Board.

4. To file with the Board affidavit evidence proving the above service and publication immediately both electronically and by hard copy, upon completion, with the relevant Notices, Application, and original Post Office Registration Receipts (where applicable) attached as appendices.

NOTE B: The affidavits of service referred to above must confirm that the Municipal Clerks served are the clerks of all affected municipalities, that the Native Bands and Native Reservations served are <u>all</u> of the Bands and Reservations affected, that the utilities and railway companies served are all utilities and railway companies whose lines would be crossed by the proposed pipeline, and that the property owners and encumbrancers so served are all owners and encumbrancers affected by the proposed construction.

As well, the affidavits of publication referred to above must confirm that the newspapers in which the Notice was published are newspapers having the highest paid circulation, according to the best information available, in all the affected municipalities. (It is not necessary for the affidavits of publication to have newspapers tearsheets attached.)

 To make a copy of the application and evidence, and any amendments thereto, available for public review at Enbridge's office and on its website, if available; and, 6. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
