**IN THE MATTER OF** the *Ontario Energy Board Act 1998*, S.O.1998, c.15, (Schedule B);

**AND IN THE MATTER OF** an Application by Canadian Niagara Power Inc., for approval to establish a deferral account

### **PROCEDURAL ORDER NO. 1**

Canadian Niagara Power Inc. (the “Applicant” or “CNPI”) has filed an application with the Ontario Energy Board, (the “Board”) dated July 23, 2010 requesting Board approval to establish a deferral account for the purpose of recording expenses related to renewable generation connection and infrastructure investment arising from the Green Energy and Green Economy Act, 2009.

The Board has assigned File No. EB-2010-0250 to this application.

The Board issued a Notice of Application and Hearing on November 5, 2010. The Notice and the application were served by the Applicant as directed by the Board. No party requested intervenor status in this proceeding.

The Board has decided to proceed by way of a written hearing.

The Board considers it necessary to make provision for a number of procedural matters. Please be aware that further procedural orders may be issued from time to time.

### **THE BOARD ORDERS THAT:**

1. If Board staff wishes information and material from the Applicant that is in addition to the information provided in the letter of July 23, 2010 and that is relevant to the hearing, it shall request it by written interrogatories filed with the Board and delivered to the Applicant on or before **Friday January 28, 2011**.

2. The Applicant shall file with the Board, complete responses to the interrogatories on or before **Monday February 7, 2011**.
3. The Applicant shall file with the Board, any submission it wishes to, on or before **Monday February 14, 2011**.
4. Board Staff shall file with the Board, any submission it wishes to, with copies to the Applicant, on or before **Tuesday February 22, 2011**.
5. The Applicant shall file with the Board, any reply submission it wishes to, on or before **Tuesday March 1, 2011**.

All filings to the Board must quote file number EB-2010-0250. You must file two paper copies and an electronic copy through the OEB Web Portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca). If you do not have a user ID, please visit the "e-Filing Services" page on the Board's website at [www.oeb.gov.on.ca](http://www.oeb.gov.on.ca) and fill out a user ID password request.
