**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Brant County Power Inc. for an order approving just and reasonable rates and other charges for electricity distribution.

#### PROCEDURAL ORDER No. 2

Brant County Power Inc. ("Brant County") filed an application with the Ontario Energy Board (the "Board"), received on November 5, 2010 under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Brant County charges for electricity distribution. The Board has assigned the application File Number EB-2009-0125.

The Board issued Procedural Order #1 on September 24, 2010 approving the intervenors and ordering Board staff and intervenors wishing information and material from Brant County to file written interrogatories on certain specified dates, and for Brant County to reply by January 31, 2011.

By way of a letter dated January 25, 2011, Brant County requested that the deadline to provide its responses be extended to February 15, 2011. The Board grants Brant County's request.

Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

#### THE BOARD ORDERS THAT:

1 The date for Brant County to file with the Board and deliver to intervenors complete responses to all interrogatories is extended from January 31, 2011 to February 15, 2011.

All filings to the Board must quote file number EB-2010-0125, be made through the Board's web portal at <a href="www.errr.oeb.gov.on.ca">www.errr.oeb.gov.on.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="www.oeb.gov.on.ca">www.oeb.gov.on.ca</a>. If the web portal is not available you may email your document to the <a href="BoardSec@oeb.gov.on.ca">BoardSec@oeb.gov.on.ca</a>. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies. If you have submitted through the Board's web portal an e-mail is not required.
