**Re: Application for an Electricity Generation Licence

The Board has reviewed your application for an electricity generation licence under the Standard Offer Program. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Under Board electricity generation licence EG-2006-0336, First Solar Development (Canada), Inc. ("First Solar") owns and operates the generation facilities identified in your application.

For the Board to continue processing your application for ownership of these generation facilities, First Solar is required to provide the Board with a written confirmation that upon completion of the commercial transaction and transfer of assets concerned, to remove ownership authority and to confirm that it will continue with operational authority only.

2. The RESOP contracts are between First Solar and Ontario Power Authority ("OPA"). Please provide proof that OPA will be approving or has approved assignment and notation of these contracts from First Solar to ABW Solar General Partnership ("ABW").
3. Please provide a copy of the assignment and notation agreement with the applicable local distribution company for each generation facility to show the change from First Solar to ABW.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
