**Re: Ontario Power Authority - 2011 Revenue Requirement Submission
Ontario Energy Board File No. EB-2010-0279**

The Ontario Power Authority (“OPA”) is writing to file its responses to the interrogatories of Board Staff and Intervenors. The OPA is also filing a directive it received from the Minister of Energy dated February 3, 2011 (Exhibit A-5-4), along with an update to the complete list of directives (Exhibit A-5-1).

The OPA wishes to note that a number of the interrogatories have raised issues which the OPA believes to be beyond the scope of this proceeding. These include questions that ask for costs beyond 2011, budgeted and actual amounts for expenditures that are recovered through charges and details of OPA program design. The OPA has responded to these questions in an effort to be of assistance to the parties. The fact that the OPA has provided an answer to these interrogatories should not be taken as any indication that the OPA considers these areas of enquiry to be appropriate for the revenue requirement proceeding.
