**AND IN THE MATTER OF** an application by Parry Sound Power Corporation for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2011.

## **PROCEDURAL ORDER NO. 2**

Parry Sound Power Corporation ("Parry Sound") filed an application with the Ontario Energy Board (the "Board") on October 15, 2010 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Parry Sound charges for electricity distribution, to be effective May 1, 2011. The Board assigned File Number EB-2010-0140 to this application.

The Board issued a Notice of Application and Hearing on November 4, 2010. Procedural Order No. 1 was issued on November 30, 2010 which approved the intervenor and cost eligibility status of the Vulnerable Energy Consumers Coalition ("VECC") and also set the initial steps for this proceeding. The Board also indicated that it would proceed by way of a written hearing.

Interrogatories were submitted to Parry Sound by Board staff and VECC on December 16 and December 20, 2010, respectively. Parry Sound provided its interrogatory responses on February 2, 2011.

The Board has decided to make provision at this time for a supplementary round of written interrogatories after which the Board will determine next steps, and/or whether to conduct an oral hearing or to make provision for written submissions.

The Board may issue further procedural orders from time to time.

## THE BOARD ORDERS THAT:

- Board staff and intervenors shall file their supplementary round of interrogatories on or before February 25, 2011. These interrogatories are to be designed to clarify or expand on the responses provided in the first round of interrogatories.
- Parry Sound Hydro shall file with the Board complete responses to all supplementary interrogatories and deliver them to all parties no later than March 18, 2011.

All filings to the Board must quote the file number, EB-2010-0140, be made through the Board's web portal at <u>www.errr.oeb.gov.on.ca</u>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>www.oeb.gov.on.ca/OEB/Industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
