**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Sioux Lookout Hydro Inc. for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2008.

## PROCEDURAL ORDER No. 2

Sioux Lookout Hydro Inc. filed an application with the Ontario Energy Board, received on October 3, 2007 under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Sioux Lookout Hydro Inc. charges for electricity distribution, to be effective May 1, 2008. The Board has assigned the application file number EB-2007-0785. The Board issued a Notice of Application and Hearing dated October 18, 2007. The Board received no interventions.

The Board issued Procedural Order No. 1 on November 26, 2007, which established a schedule for the filing of interrogatories, responses to interrogatories, submissions by Board staff and any reply submissions by Sioux Lookout Hydro Inc.

On December 3, 2007 Sioux Lookout Hydro Inc. requested an extension to the filing date for interrogatory responses. This order addresses that request. Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

## THE BOARD ORDERS THAT:

- 1. The applicant shall file with the Board complete responses to the interrogatories no later than January 11, 2008.
- 2. Board staff shall file any submissions on the application by January 28, 2008.

- 3. If the applicant wishes to reply, the reply submission must be filed with the Board by February 4, 2008.
- 4. All filings to the Board must quote file number EB-2007-0785, be made through the Board's web portal at <a href="www.errr.oeb.gov.on.ca">www.errr.oeb.gov.on.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="www.oeb.gov.on.ca">www.oeb.gov.on.ca</a>. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
- 5. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
