**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Brant County Power Inc. for an order approving just and reasonable rates and other charges for electricity distribution.

#### PROCEDURAL ORDER No. 3

Brant County Power Inc. ("Brant County") filed an application with the Ontario Energy Board (the "Board"), received on November 5, 2010 under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Brant County charges for electricity distribution. The Board has assigned the application file number EB-2010-0125.

The Board issued Procedural Order #1 on December 24, 2010 approving the list of intervenors and ordering Board staff and intervenors wishing information and material from Brant County to file written interrogatories by certain specified dates, and for Brant County to reply by January 31, 2011. Procedural Order No. 2 extended the date for interrogatory responses to February 15, 2011.

The Board has reviewed the interrogatory responses and has decided to make provision at this time for a technical conference followed by a settlement conference after which the Board will determine whether to conduct an oral hearing or to make provision for written final submissions.

Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

#### THE BOARD ORDERS THAT:

- 1 A transcribed Technical Conference will be convened on March 16, 2011, starting at 9:00 a.m. If necessary, the Technical Conference will continue on March 17, 2011 starting at 9:00 a.m. The Technical Conference will be held at 2300 Yonge Street, Toronto in the Board's West Hearing Room on the 25th Floor. Intervenors and Board staff should file their questions with the Board and forward them to Brant County by March 8, 2011.
- 2 A Settlement Conference will be convened on March 22, 2011, starting at 9:00 a.m. If necessary, the Settlement Conference will continue on March 23, 2011 starting at 9:00 a.m. The Settlement Conference will be held at 2300 Yonge Street, Toronto in the Board's ADR Room on the 25th Floor.
- 3 Any proposed Settlement Agreement arising from the Settlement Conference shall be filed with the Board by April 6, 2011. In addition to outlining the terms of any settlement, the proposed Settlement Agreement should contain a list of any unsettled issues.

Upon reviewing the proposed Settlement Agreement, the Board will determine next steps and a procedural order will be issued to that effect.

All filings to the Board must quote file number EB-2010-0125, be made through the Board's web portal at <a href="www.errr.ontarioenergyboard.ca">www.errr.ontarioenergyboard.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.
