NOTICE OF APPLICATIONS AND HEARING
Electricity Retailer Licence
Gas Marketer Licence
Summitt Energy Management Inc. on behalf of Summitt Energy LP

Summitt Energy Management Inc. on behalf of Summitt Energy LP (“Summitt”) filed an application with the Ontario Energy Board (the “Board”) dated December 3, 2010 under section 60 of the of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B (the “Act”) to renew its electricity retailer licence. The granting of this licence would enable the applicant to continue to retail electricity in Ontario. The Board has assigned the application file number EB-2010-0368.

Summitt also filed an application with the Board dated December 3, 2010 under section 50 of the Act to renew its gas marketer licence. The granting of this licence would enable the applicant to continue to market natural gas in Ontario. The Board has assigned the application file number EB-2010-0369.

How to see Summitt’s Applications

Copies of the applications are available for inspection at the Board’s office in Toronto and at Summitt’s office and may be posted on its website.

Written Hearing

The Board intends to proceed with this matter by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant within **12 days** of the issuance date of this notice.

How to Participate

You may participate in these proceedings in one of three ways:

1. Become an Intervenor

Intervenors participate actively in the proceedings (i.e., submit written questions, evidence, and arguments, and cross-examine witnesses at an oral hearing).

A request for intervenor status must be made by letter of intervention and be received by the Board no later than **12 days** from the issuance date of this notice. A letter of intervention must include: (a) a description of how you are, or may be, affected by the outcome of these proceedings; (b) if you represent a group, a description of the group and its membership; and (c) whether you intend to seek an award of costs and the grounds for your cost award eligibility.

You must provide a copy of your letter of intervention to the applicant.

Everything an intervenor files with the Board, including the intervenor's name and contact information, will be placed on the public record, which means that all filings will be available for viewing at the Board's offices and will be placed on the Board's website.

If you already have a user ID, please submit your intervention request through the Board's web portal at www.errr.ontarioenergyboard.ca. Additionally, two paper copies must be submitted to the address set out below.

If you do not have a user ID, visit the Board's website under e-Filing Services and complete a user ID/password request form. For instructions on how to submit documents and naming conventions please refer to the RESS Document Guidelines found at www.ontarioenergyboard.ca/OEB/Industry, e-Filing Services.

The Board also accepts interventions by e-mail, at the address below, and again, two additional paper copies are required. Those who do not have internet access are required to submit their intervention request on a CD in PDF format, along with two paper copies.

2. Send a Letter with your Comments to the Board

If you wish to comment on the proceedings without becoming an intervenor, you may submit a letter of comment to the Board Secretary.

All letters of comment sent to the Board will be placed on the public record, which means that the letters will be available for viewing at the Board's offices and will be placed on the Board's website.

Before placing the letter of comment on the public record, the Board will remove any personal (i.e., not business) contact information from the letter of comment (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter of comment will become part of the public record.

A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to the applicant and the decision maker.

Your letter of comment must be received by the Board no later than **30 days** from the issuance date of this notice. The Board accepts letters of comment by either post or e-mail at the addresses below.

3. Become an Observer

Observers do not participate actively in the proceedings but receive documents issued by the Board in the proceedings. There is no fee for observers to receive documents issued by the Board.

A request for observer status must be made in writing and be received by the Board no later than **12 days** from the issuance date of this notice. The Board accepts observer request letters by either post or e-mail at the addresses below.

All letters requesting observer status will become part of the public record, which means that the letters will be available for viewing at the Board's offices and will be placed on the Board's website.

Before placing the request for observer status on the public record, the Board will remove any personal (i.e., not business) contact information from the request (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the request for observer status will become part of the public record.

Observers may also request documents filed by the applicant and other parties to the proceedings but must request these documents directly from the relevant party. Observers may be required to pay for the costs of reproducing and delivering the material.

Most documents filed in these applications will also be available on the Board's website.
