EB-2010-0295: Recovery of Late Payment Penalty ("LPP")**

Dear Ms. Walli,

On February 22, 2011 the Ontario Energy Board (the "Board") issued their Decision and Order related to recovery of the LPP by Electricity Distributors (the "Decision"). The Board found that the costs and damages arising from the LPP class action shall be recovered from all rate payers of the Affected Electricity Distributors.

Hydro Ottawa is one of the Affected Electricity Distributors as listed in Appendix A of the Decision and currently has an IRM application before the Board (reference EB-2010-0326). The Decision directed Distributors to file with the Board, within seven days of the date of the Decision, detailed calculations outlining the derivation of the rate riders based on the methodology outlined in the Decision.

Please find attached Hydro Ottawa's derivation of the proposed LPP rate riders, which will recover Hydro Ottawa's share of the class action costs over a 12-month period starting May 1, 2011.
