In accordance with the Ontario Energy Board Decision ("OEB") EB-2010-0295 regarding recovery of late payment penalty amounts from customers, Bluewater Power Distribution Corporation ("Bluewater Power") hereby requests recovery as part of its 2011 IRM application EB-2010-0065 the amount of \$149,121.96 as indicated in Appendix A – Decision and Order.

Bluewater Power has calculated the appropriate fixed charge rate rider using the distribution revenue and number of customers/connections data from Section 2.1.5 of the RRR filing submitted on May 11, 2010, for the period ending December 31, 2009.

Included with this letter are the following schedules:

- 1. Schedule 1 Excerpt from Section 2.1.5 RRR for period ending December 31, 2009 to validate the distribution revenue and number of customers/connections.
- 2. Schedule 2 Detailed calculation of the specific rate rider requested for each rate class based on the methodology specified in the OEB Decision.

Bluewater Power requests approval to include the rate riders as submitted as part of the approved rates effective May 1, 2011 to be collected over a 12 month period.
