**EB-2010-0295 – OEB Cost Recovery - Late Payment Penalty Class Action Settlement –
 Hydro One Brampton Networks Inc Response to the February 22, 2011 Decision and Order**

I am writing to you as counsel for Hydro One Brampton Networks Inc. (“Brampton”).

Item #5 in the above-noted Order of the Board directed various electricity distributors, including Brampton, to file, within seven days after the date of the Order, detailed calculations and supporting documentation outlining the derivation of the rate riders based on the methodology outlined in the said Decision and Order.

This letter is being sent to the Board to satisfy the requirement of the above-noted Order. The prescribed methodology was used to prepare the following per customer rate:
