Sample letter to the 6 customers that the applicants propose to transfer from Whitby Hydro Electric Corporation to Veridian Connections Inc.

YOUR ELECTRICITY DISTRIBUTOR MAY BE CHANGING

Dear customer:

As you know, you are currently a customer of Whitby Hydro Electric Corporation and receive your electricity bills from Whitby Hydro Electric Corporation. However, you may not know that your electricity is supplied by Veridian Connections Inc. You are within one electricity distributor's service area but are actually served electricity from a second electricity distributor. This arrangement is known as a long term load transfer.

The Ontario Energy Board requires electricity distributors to eliminate long term load transfer arrangements before January 31, 2009.

Both Veridian Connections Inc. and Whitby Hydro Electric Corporation have applied to the Board for an order approving your transfer to Veridian Connections Inc. If the Board approves the transfer, you will be supplied and billed by Veridian Connections Inc. This means that you will become a customer of Veridian Connections Inc. and your electricity rate may change.
