## PROCEDURAL ORDER No. 3

TransCanada Power Transmission (Ontario) L.P. ("TransCanada") filed an application with the Ontario Energy Board, received on October 27, 2010, under section 60 of the *Ontario Energy Board Act, 1998,* S.O. 1998, c. 15, Schedule B.

The Board's Notice of Application and Hearing was issued on November 19, 2010. Hydro One Networks Inc. and Great Lakes Power Transmission L.P. filed intervention requests. The Power Workers' Union and Canadian Niagara Power Inc. requested observer status. The requests for intervenor and observer status were granted. The Independent Electricity System Operator filed a late intervenor request, received on February 8, 2011. The Board granted this request on the basis that the IESO accepted the record of the case to date.

The Board issued Procedural Order No. 1 on December 14, 2010, providing for interrogatories and submissions. On February 9, 2011 the Board issued Procedural Order No. 2 extending the dates for submissions and seeking views from all parties on the exemptions requested by TransCanada. Submissions were received from Board staff and intervenors on February 16, 2011 and February 23, 2011, respectively. On March 3, 2011, TransCanada filed a request for an extension of time to file its reply submission as it requires additional time to consider the various ways to address the specific submissions, some of which could entail establishment of measures requiring inter-company arrangements. TransCanada has requested an extension until April 15, 2011. The Board approves this request.

Accordingly, the Board considers it necessary to make provision for the following procedural matter. Please note that this Procedural Order may be amended, and further procedural orders may be issued from time to time.

## THE BOARD ORDERS THAT:

1. If TransCanada wishes to file a reply submission, the submission must be filed with the Board by **April 15, 2011**.

All filings to the Board must quote the file number, EB-2010-0324, be made through the Board's web portal at <u>www.errr.ontarioenergyboard.ca</u>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
