**IN THE MATTER OF** the *Ontario Energy Board Act,* 1998, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application under section 60 of the *Ontario Energy Board Act, 1998,* S.O. 1998, c. 15, Schedule B for an electricity transmission licence.

## PROCEDURAL ORDER No. 2

Chatham-Kent Transmission Inc. ("Chatham-Kent") filed an application with the Ontario Energy Board (the "Board"), received on November 16, 2010, under section 60 of the *Ontario Energy Board Act, 1998,* S.O. 1998, c. 15, Schedule B.

The Board issued a Notice of Application and Hearing on December 14, 2010. Hydro One Networks Inc., EnWin Utilities Ltd. and the Power Workers' Union filed intervention requests. Veridian Connections Inc. requested observer status. The requests for intervenor and observer status were granted.

The Board issued Procedural Order No. 1 on January 14, 2011, providing for interrogatories, responses to interrogatories and submissions. Board staff and intervenors filed interrogatories on February 4, 2011 and Chatham-Kent filed its interrogatory responses on February 18, 2011. Board Staff and intervernors filed submissions on March 4, 2011.

On that same date, March 4, 2011, the Independent Electricity System Operator (the "IESO") filed a late intervenor request and confirmed that it will accept the record of the case as filed. The Board notes that the IESO also provided submissions on Chatam-Kent's application in its letter of March 4, 2011. Chatham-Kent did not raise an objection to the IESO late intervention request however requested additional time to file its reply submission to respond to the IESO's submission. The Board has determined

that, although the deadline for filing submissions was March 4, 2010, it will grant the IESO intervenor status and accept the letter of March 4<sup>th</sup>, 2010 as the IESO submission as it may be of assistance to the Board when considering the issues in this proceeding.

With respect to Chatham-Kent's request for an extension of time to file its reply submission, it indicated that it requires additional time to examine the issues raised by the IESO regarding secure management of IESO specific confidential information and compliance with applicable provisions of the Affiliate Relationship Code and Market Rules that have not been raised previously in this proceeding. Chatham-Kent has requested an extension until March 25, 2011. The Board approves this request.

Accordingly, the Board considers it necessary to make provision for the following procedural matter. Please note that this Procedural Order may be amended, and further procedural orders may be issued from time to time.

## THE BOARD ORDERS THAT:

1. If Chatham-Kent wishes to file a reply submission, the submission must be filed with the Board by **March 25, 2011**.

All filings to the Board must quote the file number, EB-2010-0351, be made through the Board's web portal at <a href="www.errr.ontarioenergyboard.ca">www.errr.ontarioenergyboard.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="www.ontarioenergyboard.ca">www.ontarioenergyboard.ca</a>. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
