Letter Requesting Intervenor Status for Goldcorp Inc.

I am writing on behalf of Goldcorp Inc. ("Goldcorp"), requesting intervenor status in this proceeding. Goldcorp is a large international mining corporation based in Vancouver, British Columbia. Its gold mines at the Balmertown and Cochenour sites in Red Lake, Ontario, are the initial customers for phase I of Union's system expansion in the Red Lake area. Goldcorp is engaged in a major expansion of its facilities there. Goldcorp is also making a substantial contribution-in-aid of construction to Union to enable their facilities expansion to meet the Board's economic threshold. The contribution-in-aid will include the municipality of Red Lake's share of pipeline common costs.

Goldcorp intends to make submissions in the proceedings in support of Union's application, and, generally, will participate actively in the proceedings.

Goldcorp does not seek an award of costs in this proceeding.
