Re: EB-2010-0141: St. Thomas Energy Inc. ("St. Thomas") 2011 Electricity Rate Application

We are counsel to Rogers Cable Communications Inc. ("Rogers") in respect of the captioned proceeding. Please accept this letter as Rogers' request for intervention herein.

Description of the Intervenor

Rogers is an integrated cable and communications company that receives electricity for its cable signal amplification power supplies from distributors throughout Ontario, including St. Thomas. Rogers' power supplies are connected to local distribution systems, and are generally served on an unmetered basis (as "Unmetered Scattered Load", or "USL").

Impact of the Application on the Intervnor

Rogers' interest in this application is primarily focused on its rate treatment, including the metering of its load and the indication by St. Thomas of its intention to eliminate the Unmetered Scattered Load customer Class at the outset of the 2011 Rate Year.

Rogers may have other issues of interest to raise following full review of the pre-filed evidence herein.
