**REQUEST FOR INTERVENOR STATUS
OF
UNION GAS LIMITED**

1. Union Gas Limited (“Union”) hereby applies for Intervenor Status in this proceeding.
2. Union is an Ontario Corporation with its Registered Office at the Municipality of Chatham-Kent, in the Province of Ontario. Union is a regulated public utility, which combines the operations of selling, distributing, transmitting and storing natural gas within the meaning of the *Ontario Energy Board Act, 1998*.
3. Union has a direct interest in all matters of jurisdiction, substance and procedure in the regulation of public utilities, and in any decision of this Board, which may create a precedent affecting Union’s operations and/or rates.
4. Union requests one copy of the evidence and submissions of the Applicant and other Intervenor, and any notices or correspondence. This includes any revisions or amendments, which may be made prior to the commencement of, or during the hearing of this Application. Union’s preference would be to receive one paper and one searchable electronic version of the original prefiled evidence and then searchable electronic versions of any filings after that.
5. At this time, it is Union's intention to monitor the proceeding; however, after reviewing the evidence, Union may wish to address one or more of the issues raised. Union does not have any comments on the draft issues list issued by the Board.
6. Union reserves the right to adduce evidence, submit interrogatories, advance argument and participate in the hearing as circumstances may require. Union does not have a preference for either a written or an oral hearing.
