PROCEDURAL ORDER NO. 1

Enersource Hydro Mississauga Inc., (“Enersource”) filed an application with the Ontario Energy Board on January 27, 2011, under section 74 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B for a licence amendment seeking an exemption from their mandated date for implementation of Time-Of-Use Pricing for Regulated Price Plan consumers. The Board assigned the application file number EB-2011-0028.

The Board issued a Notice of Application and Written Hearing for the proceeding on February 25, 2011. That Notice required any party seeking further information on the application to file written interrogatories by March 18, 2011. On March 16, 2011, Enersource filed a letter with the Board amending its application and introducing new evidence as to why it will not be able to meet its mandatory TOU pricing date. Enersource also adjusted its proposed new mandatory date requesting an indefinite extension.

On March 18, 2011, Board staff requested additional time to file interrogatories. Board staff submitted that additional time was required to review the evidence and the revised request contained in the March 16, 2011 letter from the applicant. No other parties have intervened in the application.

It is important to have a complete record for the determination of this application, and interrogatories regarding the new evidence filed will assist in completing the record. I will therefore grant the request for extension of time to file interrogatories. The dates for subsequent steps in the proceeding will also be adjusted accordingly.

Please note that this Procedural Order may be amended, and further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

The dates set out in the Notice of Application and Written Hearing in this application are amended as follows:

1. Any party wishing to ask interrogatories on the application must file interrogatories with the Board, and deliver them to the applicant, by **March 25, 2011**.
2. The applicant must file a complete response to the interrogatories with the Board by **April 8, 2011**.
3. Any party wishing to make a submission on the application must file that written submission with the Board, and deliver it to the applicant, by **April 22, 2011**.
4. If the applicant wishes to respond to a submission, the response must be filed with the Board by **May 6, 2011**.

All filings to the Board must quote file number EB-2011-0028, be made through the Board's web portal at www.errr.ontarioenergyboard.ca, and consist of two paper copies and one electronic copy in searchable/unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to the address below.
