**Re: Notice of Proposal under Section 81 of the *Ontario Energy Board Act, 1998* by  
Amik-BBF Hydrokap L.P. - EB-2010-0392  
Amik-CTR HydroKap L.P. - EB-2010-0393  
Nipiy-WOF HydroKap L.P. - EB-2010-0394  
Nipiy-OWF HydroKap L.P. - EB-2010-0395**

Amik-BBF Hydrokap L.P., Amik-CTR HydroKap L.P., Nipiy-WOF HydroKap L.P. and Nipiy-OWF HydroKap L.P. (the “Notifying Parties” or “Prospective Generators”) filed with the Ontario Energy Board (the “Board”) individual notices under section 81 of the *Ontario Energy Board Act, 1998* (the “Notices”) of their proposal to construct and own a 25kV distribution line and four 7.5 MVA substations in order to connect their respective generation facilities<sup>1</sup> to Hydro One Networks Inc.’s (“HONI”) distribution system.

According to the Notices, the four generation facilities will be connecting to the proposed 25kV distribution line at different points. Ownership of the proposed 25kV distribution line will be split between the four Prospective Generators using the line. However, the four generation facilities and the associated 7.5 MVA substations will be individually owned by the Prospective Generators.

The Board understands that the proposed distribution assets will be constructed and used solely for the purpose of conveying electricity from the subject generation facilities to HONI's distribution system and ultimately to the IESO-controlled grid and for no other purpose.

This letter is to inform you that the Board will not issue a notice of review of the proposal.
