LETTER OF DIRECTION

Dear Mr. Tack Lee

**Re: Grand Renewable Wind LP
Application for leave to construct Transmission Facilities
Application Board File Number EB-2011-0063**

The Board has issued its Notice of Application ("the Notice") with respect to the above matter.

You are directed to:

1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed line and facilities.
2. To immediately serve a copy of each of the Notice and the Application, either personally, by courier, or by registered mail upon:
 - a. All directly affected property owners and encumbrancers with lands or interest in lands identified by the search of title referred to above, including;
 - the two land owners who each signed the Transition Station Lease;

- the third landowner expected to sign the Interconnection Station Lease; and
 - the 53 landowners identified in the pre-filed evidence in paragraph 57, whose properties border the Haldimand right of way ("ROW").
- b. Hydro One Networks Inc.;
- c. Each electricity distributor within whose service area the proposed line and facilities are or will be located;
- d. All generators connected directly to the Hydro One Networks Inc. transmission lines to which the proposed line will connect;
- e. All transmission customers of Hydro One Networks Inc. connected directly to the transmission lines to which the proposed line will connect;
- f. All owners and operators of rail lines, telecommunications (e.g., telephone) or other utilities along or crossing the routes proposed for the project;
- g. The Clerks of all Municipalities that would be affected by the project;
- h. All Aboriginal groups with any interest in the lands affected by the subject project, including the Six Nations of the Grand River, as well as the Métis Nation of Ontario being a representative of Métis Communities in Ontario.
- i. The following provincial government ministries and agencies :
- (i) Ministry of Energy;
 - (ii) Ministry of Infrastructure;
 - (iii) Ministry of Environment;
 - (iv) Ministry of Natural Resources
 - (v) Ministry of Aboriginal Affairs;
 - (vi) Ontario Realty Corporation;
 - (vii) Ministry of Transportation;
 - (viii) Ministry of Government Services;
 - (ix) Ministry of Municipal Affairs and Housing;
 - (x) Ministry of Culture;

- (xi) Ministry of Tourism;
- (xii) Ministry of Attorney General;
- (xiii) Ministry of Agriculture, Food and Rural Affairs;
- (xiv) Electrical Safety Authority;
- (xv) Independent Electricity System Operator; and
- (xvi) Ontario Power Authority;

3. To immediately arrange for the enclosed English version of the Notice, headed with the Ontario Government logo and the words "Ontario Energy Board", in one edition of each of the English language newspapers having, according to the best information available, the highest paid circulation in the County of Haldimand, and in the City of Hamilton.
4. To immediately arrange for the enclosed French version of the Notice headed with the Ontario Government logo and the words "Commission de l'Énergie de l'Ontario", to be published in one issue of the weekly French language newspaper having the highest circulation, according to the best information available, in the City of Hamilton.

NOTE: Please make it clear to each newspaper that invoices regarding publication are not to be sent to the Board.

5. To file with the Board affidavit evidence proving the above service and publication immediately upon completion, with the relevant Notices, Application, and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices. It is not necessary for the affidavits of publication to have newspaper tear sheets attached.
6. To immediately, or as soon as it is ready, have copies of the Application, the pre-filed evidence and any additional materials as they are developed, made available for convenient public perusal at the head office of Grand Renewable Wind, LP ("GRW") and the office of its counsel and at other offices if so identified in the Notice, and to post all such documents on GRW's website.
7. To immediately provide copies of the Application and pre-filed evidence and any additional materials as they are developed, to the offices of the municipalities listed

in the Notice, if any, and to request them to make such documents available for convenient public perusal.

8. To immediately provide a copy of GRW's Application and pre-filed evidence, and any additional materials as they are developed, to any person upon request.
