Re: Capital Power GP Holdings Inc.; Leave to Intervene in Proceeding EB-2011-0027

We are writing on behalf of Capital Power GP Holdings Inc., as general partner of Capital Power L.P. ("Capital Power"), to request leave of the Ontario Energy Board ("Board") to intervene in the EB-2011-0027 proceeding beyond the time that is stipulated in the Notice of Application and Hearing ("Notice").

Capital Power is developing a new 104.4 MW windfarm – the Port Dover and Nanticoke Windfarm ("Port Dover Windfarm") – in Nanticoke, approximately 1 kilometre ("km") from the proposed Summerhaven Wind Energy Centre ("Summerhaven"). The Port Dover Windfarm project was awarded a power purchase contract by the Ontario Power Authority under the Feed-in-Tariff Program and is expected to commence commercial operation in October 2012 or earlier. It will connect to the transmission system of Hydro One Networks Inc. ("Hydro One") on its 230 kV circuit N2M, at or near the intersection with Concession Road 5, approximately 7 km north of Hydro One's Nanticoke Transmission Station. Hydro One and the Independent Electricity System Operator have issued a Customer Impact Assessment and a System Impact Assessment Final Report, respectively, for the project.

Capital Power has registered encumbrances on seven parcels of land that will be directly affected by Summerhaven's proposed transmission line and related facilities and, accordingly, was served with a copy of the Notice sometime in the week of March 7, 2011. Unfortunately, the matter did not come to counsel's attention until the week of March 28th.

Capital Power seeks leave to intervene in this proceeding because it has a direct and material interest in Summerhaven's application in light of its encumbrances on lands affected by the proposed transmission line, the proximity of its Port Dover Windfarm to the applied-for facilities and the fact that both projects will be connecting to Hydro One's 230 KV line (albeit to different

circuits). As Capital Power is prepared to accept the EB-2011-0027 record as of the date its intervention is accepted, Summerhaven will not be disadvantaged in any way.

Capital Power reserves the right to direct written interrogatories to Summerhaven and make submissions in accordance with procedural orders issued by the Board. As the Board has indicated that it will reserve its decision on whether to proceed by way of an oral hearing until after the completion of the interrogatory phase, Capital Power has no submissions to make in this regard. Finally, Capital Power does not intend to seek an award of costs.
