**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Parry Sound Power Corporation for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2011.

## PROCEDURAL ORDER NO. 3

Parry Sound Power Corporation ("Parry Sound Power") filed an application with the Ontario Energy Board (the "Board") on October 15, 2010 under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Parry Sound Power charges for electricity distribution, to be effective May 1, 2011. The Board assigned File Number EB-2010-0140 to the application.

The Board issued a Notice of Application and Hearing on November 4, 2010. Procedural Order No. 1 was issued on November 30, 2010 which approved the intervenor and cost eligibility status of the Vulnerable Energy Consumers Coalition ("VECC") and also set the initial steps for the proceeding. The Board also indicated that it would proceed by way of a written hearing.

Interrogatories were submitted to Parry Sound Power by Board staff and VECC on December 16 and December 20, 2010, respectively. Parry Sound Power provided its interrogatory responses on February 2, 2011.

Procedural Order No. 2 was issued on February 15, 2011 providing for a supplementary round of interrogatories. Board staff and VECC submitted supplementary

interrogatories to the applicant on February 25, 2011 and responses were filed by Parry Sound Power on March 14, 2011.

The Board has determined that this application will now proceed by way of written submissions.

The Board may issue further procedural orders from time to time.

## THE BOARD ORDERS THAT:

- 1. Parry Sound Power shall file its Argument-in-Chief with the Board on or before April 13, 2011, focusing on any updates or changes it wishes to make to the application as a result of the interrogatory process.
- 2. Board staff shall file written submissions on the application with the applicant and intervenors on or before April 26, 2011. VECC shall file written submissions on or before April 29, 2011.
- 3. Parry Sound Power shall file reply submissions with the Board on or before May 13, 2011.

All filings to the Board must quote the file number, EB-2010-0140, be made through the Board's web portal at <a href="www.errr.oeb.gov.on.ca">www.errr.oeb.gov.on.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="www.oeb.gov.on.ca/OEB/Industry">www.oeb.gov.on.ca/OEB/Industry</a>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
