**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Brant County Power Inc. for an order approving just and reasonable rates and other charges for electricity distribution.

## PROCEDURAL ORDER No. 4

Brant County Power Inc. ("Brant County") filed an application with the Ontario Energy Board (the "Board"), received on November 5, 2010 under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Brant County charges for electricity distribution. The Board has assigned the application file number EB-2009-0125.

The Board issued Procedural Order No.1 on September 24, 2010 approving the intervenors, ordering Board staff and intervenors wishing information and material from Brant County to file written interrogatories by certain specified dates, and for Brant County to reply by January 31, 2011. Procedural Order No. 2 extended the date for interrogatory responses to February 15, 2001. Procedural Order No. 3 set dates for a Technical Conference, a Settlement Conference and oral hearing, and the filing of any proposed Settlement Agreement. Brant County filed a letter with the Board on April 5, 2011, requesting an extension of the filing date for the proposed Settlement Agreement from April 6, 2011 to April 8, 2011. The Board will extend the date for filing the Settlement Agreement proposal as requested.

Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

## THE BOARD ORDERS THAT:

1 Brant County Power Inc. will file any Settlement Agreement, or partial Settlement Agreement, with the Board no later than Friday April 8, 2011.

All filings to the Board must quote file number EB-2010-0125, be made through the Board's web portal at <a href="www.errr.ontarioenergyboard.ca">www.errr.ontarioenergyboard.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="www.ontarioenergyboard.ca">www.ontarioenergyboard.ca</a>. If the web portal is not available you may email your document to the <a href="mailto:BoardSec@ontarioenergyboard.ca">BoardSec@ontarioenergyboard.ca</a>. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies.
