Re: Enersource Hydro Mississauga Inc. Application for Distribution Rates Effective May 1, 2011 Correction for Retail Transmission Service Rates (EB-2010-0078)

The Ontario Energy Board (the "Board") released its decision (the "Decision"), dated March 17, 2011, in the above-captioned proceeding. Among other things, the Board ordered Enersource to review the draft Tariff of Rates and Charges set out in Appendix A to the Decision, and to file with the Board a written confirmation assessing the completeness and accuracy of the draft Tariff of Rates and Charges, or provide a detailed explanation of any inaccuracies or missing information.

On March 24, 2011, Enersource confirmed completeness and accuracy in all areas except for the Late Payment Penalty rate riders pertaining to "GS < 50 kW Small Commercial (including USL)" and "GENERAL SERVICE Less than 50kW" customer classes.

Upon further review of the Retail Transmission Service Rates ("RTSR") Adjustment Workform, Enersource has noted a discrepancy between the RTSR - Network adjustment amounts in the RTSR Adjustment Workform and the corresponding amounts in the Rate Generator model.

The discrepancy is as follows:

Rate Class	RTSR - Network Adjustment per RTSR Adjustment Workform <sup>1</sup>	RTSR - Network Adjustment per Rate Generator <sup>2</sup>
Large Use > 5000kW	-0.123262	-0.826830
Street Lighting	-0.082683	-0.192113

Enersource requests that the RTSR – Network Adjustment in the Rate Generator to be updated to equal the amounts in the RTSR Adjustment Workform.
