Re: Veridian Connections Inc., 2011 Electricity Distribution Rate Application Board File No.: EB-2010-0117 – Draft Rate Order

As per the Board's Decision and Order in the above noted proceeding, Veridian Connection Inc. ("Veridian") has reviewed the draft Tariffs of Rates and Charges to assess for accuracy and completeness.

Veridian notes the following errors and/or omissions within the Tariff of Rates and Charges.

- 1. Specific Service Charges –Page 10 of 23 of the Tariff <u>and Page 22 of 23 of the Tariff:</u> Under the section of Customer Administration, two items have been omitted:
  - a. Disconnect/Reconnect at meter during regular hours \$65.00
  - b. Disconnect/Reconnect at meter after regular hours \$185.00
- 2. For Gravenhurst Service Area SENTINEL LIGHTING SERVICE CLASSIFICATION:
  - a. The rate for the Retail Transmission Rate- Line and Transformation Connection Service Rate is incorrect.

The rate on the Tariff is \$/kW 0.4667. The correct rate is \$/kW 0.4467.

Veridian notes the following errors within the Final Decision Models.

- 1. VCI\_Main\_RG\_Final Sheet L2.1 Appl For TX Connect Cell G37 \$ Adjustment for General Service Less Than 50 kW is incorrect. The model shows an adjustment of 0.000385931. The correct adjustment is -0.000385931.
- 2. VCI\_GR\_STS\_FINAL Sheet B1.1 Re-Based Bill Det & Rates Cells M26 and O26 Rate ReBal Base Service Charge and Rate ReBal Base Distribution Volumetric Rate kW for General Service 50 to 4,999 kW are incorrect. The model shows rates of 104.44 and 3.8501 respectively. The correct rates are 104.84 and 3.8647 respectively.

Veridian notes that the correction of these rates in the above noted models will result in changes to the final rates for charges and rate classes as noted below:

VCI\_Main - GENERAL SERVICE LESS THAN 50 KW - Retail Transmission Rate - Line and Transformation Connection Service Rate

VCI\_GR - GENERAL SERVICE 50 - 4,999 KW - Monthly Service Charge and Distribution Volumetric Rate
