While reviewing Greater Sudbury Hydro's Tariff of Rates and Charges we noticed there were some discrepancies. We are harmonizing the West Nipissing and Greater Sudbury GS>50 kW rates this year, so the rates should have been identical and they were not so we reported this to Board Staff. They determined that the revenues were not being generated correctly due to an excel spreadsheet anomaly. The formulas in the cells were correct however the incorrect revenue amounts were being calculated. The Tariff of Rates and Charges for Greater Sudbury Hydro will have to be updated by Board Staff and re-issued as a result of this issue.

Please refer to the attached spreadsheet with the correct rates with the exception of the service charge for GS 50 to 4,999 kW which Board staff is aware that the calculation is off by one cent and they will make sure that it is correct on the final Tariff of Rates and Charges.
