**Re: EB-2010-0351 - Application by Chatham-Kent Transmission Inc. (CKT) for an Electricity Transmission Licence**

#### **Clarification of Information Provided in Reply Submission**

---

We write to clarify information provided in CKT's Reply Submission herein, previously filed, regarding the status of the South Kent Wind Project (SKWP).

Paragraph 4 of CKT's Reply Submission states as follows (emphasis added):

*The SKWP is a project arising from the agreement executed by the Ontario Government with a consortium of Samsung and the Korea Electric Power Corporation. This agreement will result in the tripling of Ontario's renewable wind and solar energy generation capacity and will lead to the construction in Ontario of manufacturing facilities for renewable energy generation components. SKWP has executed a power purchase agreement with the Ontario Power Authority, has been issued a connection impact assessment, has been allocated transmission connection capacity by Hydro One, and has a targeted commercial operation date of December, 2012.*

By way of reference the foregoing passage refers to Appendix H and page 33 of CKT's Application.

SKWP is in the process of preparing its application to the Board under section 92 of the *Ontario Energy Board Act, 1998* for leave to construct the transmission line to connect the SKWP wind generation project to Hydro One's existing transmission network. In the course of preparing that application, SKWP has brought the following points to our attention:

1. While SKWP is close to finalizing a power purchase agreement with the Ontario Power Authority (OPA), it has not as yet finalized such an agreement. Rather the

reference in Appendix H of CKT's Application to which paragraph 4 of the Reply Submission refers is to the *Green Energy Investment Agreement* entered into between the SKWP sponsors (Samsung C&T Corporation and Korea Electric Power Corporation) and the Ontario Government. It is under this agreement, and the associated September 30, 2009 Ministerial Directive to the OPA, that the SKWP has proceeded to date.

2. The connection impact assessment (CIA) issued by Hydro One regarding the SKWP is currently in draft.

We trust that this information is of assistance.
