**Hydro One Brampton Networks Inc. – 2011 Cost of Service Application
Energy Probe – Submissions re Draft Rate Order**

Pursuant to the Decision and Order, issued on April 4, 2011, the following are the Submissions of Energy Probe Research Foundation (Energy Probe) in respect of the Draft Rate Order delivered on April 11, 2011 for Hydro One Brampton Networks Inc.

Energy Probe's consultant, Mr. Randy Aiken, has reviewed the Draft Rate Order. No material discrepancies between the Board's Decision and Order and the Draft Rate Order were found.


At Page 55 of the Decision and Order, the Board indicated that it would be assisted by parties' comments on the accuracy of the revised calculations related to the exclusion of the regulatory assets and recoveries and the inclusion of the interest clawback adjustment associated with the balance in Account 1562. Energy Probe notes that the amount shown in Table 12: Calculation of Balance of Account 1562 is \$(2,841,943.24) in the Draft Rate Order. This is consistent with the figure provided in the Staff Submission dated January 14, 2011 in the table on Page 57 of those submissions. Energy Probe is relying on Board Staff submissions in this area to ensure that the figure provided is correct.
