IN THE MATTER OF the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) pursuant to Section 90(1);

AND IN THE MATTER OF an application by Union Gas Limited for an Order granting leave to construct a natural gas pipeline and ancillary facilities in the City of London and the Municipality of Middlesex Centre, in the County of Middlesex.

PROCEDURAL ORDER NO. 2

Union Gas Limited (“Union” or the “Applicant”) filed an application with the Ontario Energy Board on December 17, 2010, under section 90 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B for an order granting leave to construct approximately 6.6 kilometres of 8 inch diameter and 0.6 kilometres of 12 inch diameter natural gas pipeline, in the City of London and the Municipality of Middlesex Centre, County of Middlesex. The Board has assigned the application file number EB-2010-0381.

The Board issued a Notice of Application and Hearing on January 12, 2011. The County of Middlesex, the Corporation of the City of London, Ian Goudy of Goudy Farms Inc., Nancy Jackson and C. Harold Jackson applied for intervenor status. No objections were received, and the Board granted these requests.

As per Procedural Order No. 1, Board staff filed written interrogatories on March 16, 2011. None of the intervenors filed written interrogatories. Union filed the responses to Board staff interrogatories on April 1, 2011.

The Board considers it necessary to make provision for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. Intervenor who wish to file additional evidence that is relevant to the hearing shall file it with the Board and deliver it to the Applicant and other parties on or before April 29, 2011.
2. Parties including the Applicant who wish to file written interrogatories on the submitted intervenor evidence shall file it with the Board and deliver it to the particular intervenor on or before May 6, 2011.
3. The intervenors who have received written interrogatories to their filed evidence shall file with the Board complete responses to the interrogatories and deliver them to the other parties no later than May 20, 2011.
4. An oral hearing will be held on Tuesday, **May 24, 2011** at 9:30 a.m. in the Board's North Hearing Room on the 25th floor at 2300 Yonge Street, Toronto, Ontario. The Board reminds all parties that they must be prepared to address all the issues in the Application and any additional evidence that may have been filed.

All filings to the Board must quote the file number, EB-2010-0381, be made through the Board's web portal at www.errr.ontarioenergyboard.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
